






8:15 p.m. April 15, 2014

The fog cleared. 325 students of Danwon High school were relieved of their worries about the school trip being cancelled. They sent text messages to their families. "We'll have a great trip!"





8:45 p.m. April 15, 2014

All 475 passengers, including the ferry's crew, embarked. Industrial machinery, including excavators, trucks, and containers, were also loaded. When the last freight boarded the Sewol, the ship's weight allowance doubled.

9 p.m. April 15, 2014

The ferry departed from Incheon to Jeju island. The passengers enjoyed watching fireworks and playing limbo games on the deck. No emergency preparation was provided to the passengers.




8:49 a.m. April 16, 2014 In the morning, as the passengers were finishing breakfast, the ferry began to list to one side. Many lost their balance and fell down.



8:52 a.m. April 16, 2014

Deokha Choi, a second year student at Danwon high school, made the first emergency call to 911. Three minutes later, crewmembers aboard the Sewol also reported distress. They called the marine control center at Jeju Island, rather than the one at Jindo Island, which was closer to their location at the time.





9:32 a.m. April 16, 2014 The marine police arrive at the scene. The captain and crew of the Sewol jump into lifeboats. They escape the ship.


I'll leave the ship after all of you (Jiyoung Park, crew of the ferry and Haejeong Choi, a teacher at Danwon)

The passengers help each other while waiting to be rescued.




9:50 a.m. April 16, 2014

Although the marine police have a microphone, they do not use it to inform the passengers about the need to escape the sinking ship. They only save the passengers that are already outside.



11:00 a.m. April 16, 2014

Breaking news reports that "All Students from Danwon Were Saved." Many people are relieved. Parents bring food and clothes for their children to change into, and leave for Jindo island.




11:18 a.m. April 16, 2014 The Sewol ferry is nearly submerged, with only its prow remaining above the water.






The parents arrive at Jindo. Previous news stories about everyone being saved proves to be false. The situation room is filled with sounds of parents weeping.



5:15 p.m. April 16, 2014


President Park Geun-hae visits the Disaster and Safety Management office in Seoul. "Why haven't the victims been found if they wore life vests?"



The government announces that 178 divers are contributing to the search operation. However, only two search operations were actually conducted, with just 24 divers. Five are reported dead, and 299 missing

April 17, 2014

The victim's families board barges in order to move closer to the scene of the accident. They soon realize that the marine police are preventing private divers from getting involved in the rescue operation. It becomes apparent that many boats and divers were not able to participate in the process at all.



April 17, 2014


President Park visits Jindo gymnasium where the victim's families are staying. They protest. "Why don't you do anything to rescue the children?" "Why did you prevent the private divers from getting involved?" Security guards surrounded the families, and block them from getting close to the president.



The marine police protect the escaped captain, Lee Junseok, at an apartment, instead of investigating him at the police station. The recording from the security camera at the apartment is missing.

The victim's families are still protesting at 1 am. "Why didn't the government work faster to save the passengers?" They march from Jindo to the Blue House, requesting to meet the president. But their passage is blocked and they remain under police surveillance.

April 22, 2014 The families of survivors are angry.

They release a statement to the nation. They criticize the government and press because they continue to release false reports about the disaster. Meanwhile, the death toll increases to 121. It becomes harder to identify the victims by face as their bodies continue to deteriorate.

> April 26, 2014 All fifteen crew members aboard the Sewol are arrested. The death toll has reached 187. No one has been found alive.




May 7, 2014

The death toll is now at 269. The survivors and families hold a press conference. They plead for a thorough investigation, with the hope that they can receive answers about the accident and the delayed rescue efforts. They appeal to the country to help prevent this kind of disaster from happening again.



May 8, 2014


The report bureau chief of KBS, the public broadcasting system, states that the number of victims in the Sewol disaster is not as high as the number of people who die yearly from car accidents. The victim's families are insulted and again request a meeting with president, but are rebuked by the police. The families camp out on Chungun road in front of the Blue house, where the President lives.



May 16, 2014

One month after the disaster, President Park calls seventeen of the victims' family members to the Blue House. She promises that she will launch a full investigation, as the families wished. This is 20 days before the local election.

May 19, 2014 President Park releases a statement to the nation stating that she will disband the marine police. Upheaval ensues.



May 22, 2014

"Lets thoroughly investigate the reason for the Sewol disaster. Lets punish the people in charge, and lets protect the lives and safety of people in this country." From the "4.16 People's Committee," which has been formed by the victim's families and supporters.



May 23, 2014

The People's Committee does not trust or depend on the government and police. The families continue to stay at Jindo island and observe the search operation. They are continually assured that all evidence and remains will be collected and safely delivered to the victim's families.

June 2, 2014

28 days after the disaster, "the special committee for the investigation of state administration in regards to the Sewol disaster" is launched by the government.

June 8, 2014

Neena Yoo, a teacher at Danwon high school who stayed on the ship during the accident to help the students, is found dead. Her body is extremely decomposed. The Special Committee promised the People's Committee they would find all of the victims and that they would include the People's Committee in the investigation.



June 12, 2014

The investigation by the state administration continues to break down. The People's Committee cannot trust them anymore. They go to court and the National Assembly by themselves. They ask to preserve the evidence, document, and videotape everything regarding the disaster.



June 25, 2014

The 73 surviving students of Danwon return to school. They try to stay strong. They say "Please don't forget the Sewol ferry disaster."

The People's Committee agree upon the enactment of a special law which gives authority over the investigation to the committee. They campaign all over the country and gather people's signatures.



July 14, 2014

Even after signatures are accumulated, the government does not keep their promises to the families. They do not make the special law. Fifteen family members, including Yeong-oh Kim, father of deceased student Yoomin Kim, begin a hunger strike. It sounds like they went on a hunger strike to get more compensation!

July 14, 2014 The victim's families continue to be

The victim's families continue to be slandered across social media and the internet. These fabrications are accepted by the populace.



July 15, 2014

"Please reveal the truth of our friends' wrongful death."

46 surviving students walk 25 miles for 22 hours from Danwon high school to the National Assembly building. They plead for the establishment of a special law that the victims' families previously asked for.




July 17, 2014

The Parent's Union (a conservative right-wing political group that consists mostly of senior citizens) goes on a rampage at the Gwanghwamun Plaza, criticizing the families.



July 18, 2014

Even after many months and the change of the season, nothing has become any clearer about the disaster. The special law was never established and the number of deaths has reached 294.




July 21, 2014

Byeong-eun Yoo, president of the Semo Group and owner of the company that managed the Sewol Ferry (many believe he knows the truth about the accident), is found dead. His sudden death arouses suspicion.



July 25, 2014

The business laptop used aboard the Sewol is restored. One hundred documents titled "List of Indications from NIS (the Korean equivalent of the CIA)" are found. What is the relationship between the Sewol ferry and NIS?



August 16, 2014

Pope Francis meets the victim's families during his mass at Gwanghwamun Plaza. The families are consoled by a foreign leader, but not by their own government.






August 28, 2014

"Survive first and reveal the truth together." Responding to pleas from families and supporters, Yeong-oh Kim, the father of deceased Yoomin Kim, ends his hunger strike. Eating thin rice gruel after 46 days of fasting, he states: "I will prepare for the long fight."

August 22, 2014 "President, Keep Your Promise! Government, Make the Special Law!" The victim's families continue their protest on the Chungun road in front of the Blue house. August 30, 2014 The 90 days investigation by the state administration is over. There were no hearings and no new information has been revealed.

October 29, 2014 197 days after the disaster, and 102 days after finding the last victim, student Jeehyun Hwang's body is found. She was the 295th victim, and was found on her birthday.

November 6, 2014

The special law for the Sewol disaster is finally approved without the concent of the victim's families. The government did not keep their promise to consult with the families during the process.






November 11, 2014

The government announces that they will stop searching for bodies. There are still people inside the ferry. The total number of missing people is nine.

The captain receives 36 years in prison, the chief engineer receives 30 years, and the crew members each receive between 5 and 20 years. Even after the legal judgements are delivered at the Gwangju District Court, the reason for the disaster is still unclear.

November 18, 2014

The government closes the headquarters for the disaster rescue operations. The various people who filled the Paengmok harbor also disappear, along with the press. But the victim's families are intent on staying at the harbor until they dredge the Sewol ferry from the sea.



2015 begins ...

with the Sewol ferry and the truth buried deep beneath the sea

December 15, 2014

After the special law for Sewol ferry disaster is approved, the government begins to organize the court of inquiry. The court of inquiry is comprised of people who insulted the victims and families, corrupt prosecutors, and individuals who are preparing to run for election. The People's Committee holds a press conference to criticize the inquiry.

January 16, 2015

The court of inquiry for the Sewol ferry disaster begins, with the unqualified members still included. They try to investigate reasons for the disaster, but the discussion about salvaging of the ferry is delayed. The families of the missing people shed tears of anger.

January 22, 2015 Even before the beginning of the investigation, the court of inquiry repeatedly quarrels and make threats. Some members do not even follow the existing special law.




January 26 to February 15, 2015 The victim's families walk for 20 days from Seoul to Jindo. They continue their campaign to gain people's signatures while protesting and sleeping outside during the winter.

March 27, 2015

The Ministry of Maritime Affairs and Fisheries announce the enforcement ordinance of the special law for the Sewol ferry disaster. Under the enforcement ordinance, the government can control all of the committee's activities, making an independent investigation of the disaster impossible.







March 30, 2015

The victim's families gather in the streets of Gwanghwamun again. They are infuriated with the government and the enforcement ordinance. The families are blocked by the police, and fall down. Many are hurt as they fall down again, but they pick themselves up and continue on. April 4, 5, 6, 7..., 2015. As the families resist the enforcement ordinance, the government announces that the families will receive hundreds of millions of dollars in compensation. The press report that the families protest the amount and want to be rich. The families cannot take it anymore. They shave their hair as a form of protest.

> With photos of their deceased children hanging around their necks, the families walk overnight from Ansan to Seoul, and plead to the people. The families and their supporters protest against the government that insulted them, and walk together demanding that the Sewol ferry be salvaged and the ordinance be abolished. In offering compensation to the victims' families, the government also demands that they sign a contract forbidding the filing of grievances against the administration. The families stage another hunger strike.



April 16, 2015

304 people were killed in the Sewol Ferry disaster. The truth still has not been revealed, and the ferry remains under the water.
